Background of the International Institute for Trade and Development

During the Tenth Session of the United Nations Conference on Trade and Development (UNCTAD X) held in Bangkok between 12-19 February 2000, the meeting resolved to establish a center of research and training in the region, and to enhance the potential for trade and development in developing countries in the region and world. The Royal Thai Government and UNCTAD signed a Cooperation Agreement establishing the International Institute for Trade and Development (ITD) on 17 February 2000. The Institute was officially inaugurated

on 1 May 2002 during the Mid-Term Review Conference of UNCTAD X, hosted by the Thai Government. ITD is a government entity as a public organization established under the Royal Decree on the Establishment of the International Institute for Trade and. Development (Public Organization), B.E.2544 (2001), which aims to provide academic services for training and research in the fields of trade and development. ITD is governed by Board of Directors and has Executive Director as its chief administrator.

Mission

- To be a center of excellence in training and research in the field of international trade, finance, investment and development in order to serve the needs of public and private sectors in the region and sub-region;
- To enhance the analytical capability of developing countries in formulating trade and development policies, as well as, determining appropriate measures corresponding with the globalization in the region and sub-region;
- To foster the cooperation on trade, finance, investment and development between countries in the region and sub-region through collaborative research projects;
- To collaborate with UNCTAD and other international organizations to disseminate knowledge gained to developing countries in the region and sub-region.

The International Institute for Trade and Development (Public Organization) was inaugurated in 2002 and directed by Dr. Manaspas Xuto, the first executive director. Since the early period of operation, ITD obtained an initial fund at the amount of 35,070,700.00 Baht from the Royal Thai Government and external sources. The ITD's operating results during the fiscal year 2002 - 2015 are as followed:

Mission operations

During the fiscal years 2002 - 2015, ITD has obtained the aggregate fund from the Royal Thai Government at the amount of 461,083,899.00 Baht. The fiscal year in which ITD attained the largest amount of government fund was the year 2012 at the amount of 75,830,800.00 Baht, followed by the year 2011 at the amount of 49,564,100.00 Baht. ITD attained the smallest amount of public fund in the fiscal year 2003 at the amount of 5,000,000.00 Baht.

Furthermore, ITD received the aggregate income contribution from the external sources to finance specific projects relating to ITD's strategic objectives during the fiscal years 2002 – 2015 at the amount of 79,697,217.92 Baht. The fiscal year in which ITD attained the largest amount of external funds was the year 2009 at the amount of 11,811,485.73 Baht, followed by the year 2007 at the amount of 10,703,798.64 Baht. ITD attained the smallest amount of external fund in the fiscal year 2003 at the amount of 800,219.98 Baht.

During the fiscal years 2002 – 2015, ITD conducted 602 activities – 68 research projects; 297 training; 48 conferences and 181 seminars – with a total of 42,545 participants

2.1 Research

Research and development In the fiscal year 2014, ITD carried out 9 research projects which was the highest number since the ITD's establishment, whilst in the fiscal years 2010 and 2013 ITD carried out 8 research projects each year. During the fiscal years 2002 – 2003 which was the early period of establishment, ITD did not conduct any research projects.

2.2 Training

In the fiscal year 2012, ITD arranged 46 training which were the highest number since the establishment, followed by the fiscal year 2014 (38 training). In the fiscal year 2002, ITD arranged 4 training due to the early period of the establishment.

2.3 Conference

In the fiscal year 2013, ITD organized 14 conferences which was the highest number since the establishment, followed by the fiscal year 2006 and 2014 (7 conferences). In the fiscal years 2011 and 2012, ITD organized 1 conference each year.

2.4 Conference


In the fiscal year 2014, ITD organized 29 seminars which was the highest number since the establishment, followed by the fiscal year 2008 (24 seminars). In the fiscal years 2002 and 2013 ITD organized 5 seminars each year.

2.5 Participant




